## Car Seats for Distribution

Income eligible household may qualify for a new car seat through a distribution/referral program. Car seats are offered on a first come, first served basis and are subject to availability. All distribution appointments will take place at the car seat inspection station. Expectant parents must be in the third trimester.

## Additional Information

Car seat checks are performed by appointment only. You may experience 4-6 week wait for an appointment. Please plan accordingly. Parents and caregivers will work with CPS technicians to install car seat according to the manufacturer's guidelines. Call **309-828-1892** for an appointment.
